Rich - your thoughtful consideration coupled with your always good humor has lead us through this most extraordinary year where you not have not only overseen the regular "business at hand" but have helped us negotiate our way ably through this pandemic - doing what NABL does best – being educators and advocates!

When Kathy McKinney took the helm as president in 2009 – she noted that not only was NABL continuing to build on our substantive strengths, but that we were moving forward in terms of our we deliver content to our members and the industry. **Involvement** by NABL – This includes the continued involvement of NABL with meetings with other industry groups as we have done throughout the past year, including, but not limited to: GFOA, NAHEFFA, NAST, BDA, SIFMA, NLC, where we discuss current and future collaborative efforts and identify new and innovative ways in which we can continue to work with one another. This year, for example, the collaborative Disclosure Industry Group's (of which NABL was a member) produced a thoughtful disclosure considerations paper released in August.

Of course we continue to also benefit from continued and ongoing discussion with representatives from the SEC and IRS and are grateful for their willingness to work with NABL - which we also look forward to continuing to do over the course of this coming year.

The way we do all of this, of course - is through involvement by YOU!

**Involvement with NABL in Committees:** NABL has a number of committee in which NABL Members can become involved, including the following:

(1) Tax (Rich told you a little about what they have been doing) –as noted they have a number of short term and long term on-going projects;

- (2) our General Law and Practice Committee which just this week released the Charter School Financing paper (which they updated real time last week to include the recent SEC enforcement action);
- (3) our Publications Committee (I will be talking a little more about the recent electronic media and disclosure project in a moment during our awards ceremony),
- (4) our Securities Committee (which will shortly be releasing an updated Crafting Disclosure Policies paper, is working on a white paper on due diligence and which as I previously alluded to I hope will make progress in working with our friends at OMS to advance the update to the SEC's 1994 Interpretive Release!)
- (5) our Governmental Affairs Committee (which I will touch on more fully in a moment); and
  (6) our Diversity Committee which is hosting a virtual reception today at 6:00 pm PLEASE
  JOIN US for that you'll need a drink after hot topics in tax AND securities and hearing where we are in DC! Plus there will be an opportunity for break out groups to meet and discuss with other members.

I do need to thank Chris Langhart, Brad Patterson, Johnny Hutchinson and Elizabeth Walker whose terms have ended and who have done a fantastic job leading (respectively) the Education Committee, Securities, Tax and Governmental committees.

Finally - I'm thrilled to announce the formation of a new NABL committee NABL Issuer and In-House Counsel Committee!

The Goal of this new committee is to expand NABL's mission to promote the integrity of the municipal marketplace by (i) providing a forum for issuer's counsel, both in-house and outside, [and in-house borrower's counsel] to discuss issues of particular interest to them, (ii) working with the NABL Education Committee to provide recommendations to the NABL Board regarding

educational programming that would be beneficial, and (iii) when appropriate, producing or assisting with the review of written material for publication by NABL through its usual process.

They will be having a meeting tomorrow at 5, along with General Law and Practice, Securities and Tax. Find them on your app and join in!

Involvement in Education – NABL was established to promote the integrity of the municipal market through the education of its members in the laws affecting state and municipal bonds.
 We have A LOT of ways to do this in addition to being part of the Committees.

Seriously – please respond to the call for volunteers and reach out to me or anyone else on the board to get you in touch with the right folks if you need help in this respect!
